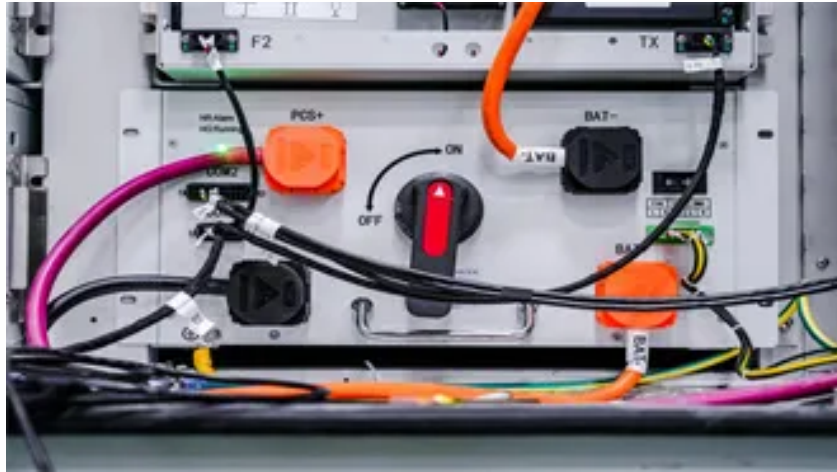


Energy storage project landing



Overview

The initial development of the project was undertaken by Dynegy Marketing and Trade (Dynegy), which was merged with Vistra Energy in April 2018. The project is located at the retired Moss Landing gas-fired power plant, which was built by PG&E near Moss Landing Harbor, Monterey County, California, US. The Moss Landing BESS phase one comprises a 300MW modular, fully integrated, pad-mounted lithium-ion battery energy storage system capable of holding 1,200MWh of electricity. The batteries were supplied by LG Energy Solution and have a. The battery energy storage facility is connected to the California Independent System Operator (CAISO) grid via the existing 500kV. Luminant, a subsidiary of Vistra Energy, was engaged in the construction of the Moss Landing phase one battery storage project. Fluence, a global energy storage technology and services specialist based in the US, was the engineering contractor for the project.

The Moss Landing battery energy storage project began operations in December 2020. Image courtesy of David Monniaux. The Moss Landing battery storage project is a massive battery energy storage facility built at the retired Moss Landing power plant site in California, US.

What is the biggest battery storage project in 2022?

The biggest project to come online during 2022 meanwhile was Crimson Energy Storage, also in California, which is 350MW/1,400MWh. Vistra has previously claimed it will have over 1.2GW of battery storage in its US portfolio by 2026.

What are energy storage technologies?

Energy storage technologies, particularly lithium battery technology, are vital for the success of this facility. Lithium batteries are a type of rechargeable battery that store energy efficiently, making them commonly used in renewable energy systems.

Why should you invest in energy storage?

"Continued investment in energy storage, like our Moss Landing site, allows us to harness and store a substantial and growing amount of power from intermittent renewables and then deliver that electricity when customers need it most."

What is Moss Landing Bess Phase 1?

The Moss Landing BESS phase one comprises a 300MW modular, fully integrated, pad-mounted lithium-ion battery energy storage system capable of holding 1,200MWh of electricity. The batteries were supplied by LG Energy Solution and have a discharge duration of four hours.

What is Moss Landing Phase 3?

PG&E's new contract for Moss Landing Phase III, also known as MOSS350, is under a 15-year term and was approved by California regulators in April 2022. Vistra Energy noted that the expansion was completed on schedule within a 16-month timeframe, adding more than 110,000 battery modules in 112 containerised units.
